We, the farm, wish to provide you with fresh, local, seasonal food and you, the member, wish to receive a portion of our harvest. This agreement outlines our shared commitments to that relationship.

Section 1. Introducing Our CSA Farm

A. Becoming a Part of Our Farm

Community Supported Agriculture (CSA) is a relationship between our farm and you as our customer. Rather than simply purchasing food, our customers become “members” of this CSA farm who receive a portion of the farm’s harvest.

Our CSA runs for 23 of weeks, from June through October with 20 boxes during that time. As a new service this year we are allowing for 3 vacation weeks over the course of the season for members to utilize at their discretion. Members are responsible for showing up at the farm, pick-up site or pay for delivery each week to pick up your share of freshly harvested

produce,meats or goods. You will generally receive a combination of the above, in the value of \$30 in the early and late season, and with a value of \$40 and up to \$50 during peak season. Detailed information regarding pick-up is discussed below in Section 3. Variety and quantity may vary as described below in Section 2.

B. Our Growing Practices

The farm practices organic principles, meat, poultry, eggs, and dairy products come from animals that are not given antibiotics or growth hormones. All produce is grown without using specific conventional pesticides, fertilizers made with synthetic ingredients or sewage sludge, bio engineering, or ionizing radiation. For more information about organic production please ask. We'd be happy to tell you more. The farm is not currently certified, but we are in the process of becoming "Certified Naturally Grown". "Certified Naturally Grown (CNG) is similar to organic certification because it requires compliance the standards for organic certification. C. The Products We Expect for 2016

The chart below outlines some of the vegetables we plan to deliver and when you may see them in your share. This chart is based on our best estimate, but of course weather, pests, and other events will affect actual production. For a complete planting list visit our web site.

Month Harvested	Expected Crops
June	Arugula, Beets, Head Lettuce, Radishes, Asian Greens, Kale Herbs, Scapes, Spinach, Cucumbers, Mesclun etc.
July to September	Beets, Broccoli Rabe, Carrots, Tomato, Peppers, Cucumber, Squash, Lettuce, Mesclun, Swiss Chard, Beans, Peas, Kohlrabi, Onion, Melons, etc.
October to November	Spinach, Chard, Arugula, Winter Squash, Beets, Carrots, etc

Section 2. Our Shared Commitments

A. Sharing in the Risk of Crop Failure

We promise to do our best to provide you with a bountiful share each week. The quantity of produce, however, may vary from week to week due to extreme weather, insects, or other production factors despite our best efforts. By joining our CSA, you are agreeing to share the risk of crop failure with us and other members. In the unlikely event of a crop failure, our procedure is as follows:

If only a small portion of crops fail, we compensate for the failed crops by filling your share with other crops grown on the farm that are ready for harvest at that time. If a large portion of crops fail, we may not be able to deliver any product in some weeks.

B. Sharing in the Reward of Crop Surplus

In addition to our CSA, our farm sells to restaurants and farmers markets. We prioritize the CSA over our other markets. We will enlarge the shares up \$50 in value during abundant harvests. This allows us to select a consistently full and diverse share to our customers while avoiding over-delivering any one product.

C. Feedback and Utilization

Feedback from membership is vital to the growth of our CSA. In order to provide the best shares it is important for us to hear from you on a regular basis about taste, shelf life and other varieties of products you are interested. Some of the products you receive may be unfamiliar to some members. We will be including recipes for more unusual items, Garlic Scape Pesto for example.

Section 3. Picking Up & Delivery

We will be offering both delivery and pick up options. Delivery pricing will be determined based on the location and number of members in immediate vicinity. All deliveries will be made in a reusable container. Last weeks must be returned upon delivery of current week.

If you choose to pick up you are responsible for picking up your share each week from your drop site. Place a check mark next to the drop site you would like to use from the list below.

You are responsible for observing our drop site rules, which are as follows:

1. Bring your own bag
2. Pick up your share within the time frame stated. Although we deliver high-quality produce to the site, it will decline quickly if not picked up in time.
3. Be respectful of our drop site hosts' property.

If you cannot pick-up your share, you must arrange for someone else to pick it up for you. You are responsible for explaining the pick-up location and procedures to your substitute. If you wish to change your drop site or become a delivery, you must give us 7 days notice. Shares that are not retrieved within the pick-up time will be donated to City Harvest.

We take the safety of your food seriously. All produce and eggs are washed at harvest. However for your added protection, wash all produce and eggs before eating and put frozen products in the freezer as soon as possible.

Section 4. Member Fees

By selling membership in advance of the growing season, CSA reduces the burden of up-front costs for the farmer. Your membership fees provide us with money to purchase seed and equipment before the season starts, and we appreciate your commitment. We depend on being able to communicate important information such as necessary changes to your distribution schedule or to our farm events. Every week we will email a listing of expected produce and any recipes or information we have to share with you.
